Note on Agricultural and Food Security development strategy

The agricultural and food security development in Côte d'Ivoire is organized as follows:

<u>At the first level</u>: the Agricultural Orientation Law that was adopted in 2015, and represents the framework for the application of agricultural development policies and strategies. It enables the harmonization and the adjustment/enrichment of the shortcomings of the existing specific laws in the agricultural sector.

<u>At the second level</u>: the National Agricultural Investment Programme (NAIP) Adopted in 2017. The NAIP provides a coherent framework for the programming of public and private investments in the agricultural and food security sector and aims at stimulating sectoral growth to reduce poverty and achieve "zero hunger" by 2025.

- ✓ Finally, this investment programme is operationalized through specific strategies for the development of agricultural sub-sectors, cross-cutting approaches to agricultural development challenges. The most important of these sub-sector development strategies are:
 - For the oil palm sector, the 3rd Palm plan;
 - For Hevea sector, the 7th Hevea project,
 - For cocoa and coffee, the Quantity, Quality and Growth (2QC) plan,
 - For food crops, National Food Crop Development Strategy other than rice;
 - For the rice sector, National Strategy for the development of the rice sector,
 - For agricultural tracks, National Rural Roads Strategy
 - For rural land, the Rural Land Policy;
 - For irrigation, Irrigation Strategic Plan;
 - For the animal and fisheries sectors, Strategy for the Development of Livestock, Fisheries and Aquaculture;
 - For resilience, a "Country Resilience Priority" program;
 - For climate change, a Climate Intelligence Agriculture Investment Plan in Côte d'Ivoire.

Other specific cross-cutting strategies such as the national agricultural training strategy, the national agricultural international cooperation strategy, the agricultural communication strategy, the strategy for the development of the cashew industry in Côte d'Ivoire currently being formulated will complement the abovementioned.

In sum, the Agricultural Orientation Law is the fundamental basis of the agricultural development and food security policy in Côte d'Ivoire, from which PNIA and other specific strategies derive from.
