Dear Mr. Yakende

Thank you for again for sending the Central African Republic's submission to GAFSP. We have reviewed the submission emails/attachments and note that the submission is incomplete and is missing: a current National Agriculture Investment Plan.

The PNIASAN is mentioned in the submission, but has not been submitted. Please also note that the PNIASAN should be current (e.g., still under implementation at this point in 2019). If the implementation period for PNIASAN has completed, per the GAFSP Country Guidelines, the country must instead submit other relevant national planning documentation, such as (i) a Malabo Declaration country implementation Roadmap, (ii) a stocktaking report that lays the basis for the formulation of a new NAIP, offering an analysis of agriculture growth options and suggesting areas for public and private investment in that context, based on the African Union Commission/NEPAD Planning and Coordination Agency (AUC/NPCA) CAADP guidelines under the Malabo Declaration and any other relevant national planning documentation.

Please kindly submit these missing documents for the CAR's submission to be considered complete, prior to close of business Monday 16th September, 2019 (11.59pm, WASHINGTON DC TIME). This is the extended deadline for missing documents and we will not be able to accept any documents sent after this deadline.

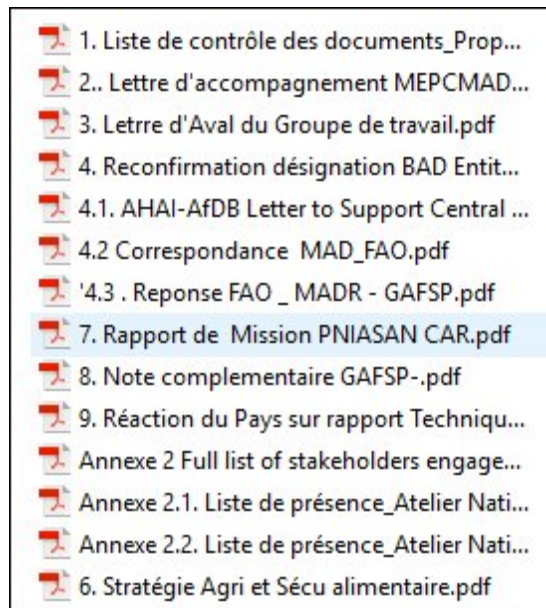
